### OBJECTIVES

This program aims to develop scholars who possess a deep, quantitative understanding of economic theories and practices, with graduates expected to make significant contributions to the field through original research and advanced economic modeling, addressing complex economic phenomena at the local, regional, and global levels.

The program emphasizes critical thinking, analytical skills, and the ability to conduct independent research, equipping students to excel in academic, governmental, and private sector roles.

### ELIGIBILITY

Applicants to the PhD program in Economics should have:

- ▶ A Master's degree in Economics, Finance, Mathematics, or a related field.
- ▶ Relevant professional experience in economic or financial analysis, ideally in institutions like central banks, economic ministries, financial institutions, or corporations.
- ▶ A strong foundation in quantitative methods, demonstrated through prior academic coursework or work experience.
